CONDITIONS

- * We sell to distributors who share our commitment to small independent retailers. Retailers who have established brick-and-mortar shops or valid online shops. We do not sell to large discounters, buying clubs/cooperatives or consignment shops.
- * We validate retailers before filling orders to determine that they are legitimate businesses with an established website or brick-and-mortar shop.

PATTERN PRICING *for Distributors*

- * Suggested Retail \$12.95. ABD wholesale price to retailers is \$6.00 USD per pattern. Wholesale price to distributors is \$4.50 USD per pattern.
- * Suggested Retail \$15.95. ABD wholesale price to retailers is \$8.00 USD per pattern. Wholesale price to distributors is \$5.60 per pattern.

TERMS AND PAYMENT OPTIONS

- * Orders are processed 2-3 times per week. Orders will be processed and shipped promptly.
- * Distributors pay shipping and freight.
- * U.S. Distributor's first order must be pre-paid by these major credit cards – Visa/Mastercard or American Express. Once payment is received, the order will be processed. We also accept money orders or cashier's check drawn on a U.S. bank account. All cashier's checks should be made out to: Art of the Midwest, LLC.
- * International Distributor's first order must be pre-paid by these major credit cards – Visa/Mastercard or American Express. We also accept payment by wire transfer/direct deposit into our U.S. bank account. Once payment is received, the order will be processed.
- * Once Credit is established after the first order, all distributors are granted an invoice account with 30 day terms.
- * FOR U.S. ORDERS - ALL INVOICES HAVE 30 DAY TERMS. Any invoices outstanding on an account will inhibit shipment of new orders. Payable by company check. All checks should be made out to Art of the Midwest, LLC.
- * FOR INTERNATIONAL ORDERS - ALL INVOICES HAVE 30 DAY TERMS. Any invoices outstanding on an account will inhibit shipment of new orders. Payable by direct deposit/wire transfer into our Art of the Midwest bank account, by major credit card, or by check in U.S. funds drawn on a U.S. bank. All checks should be made out to: Art of the Midwest, LLC.
- * WE DO NOT DO CONSIGNMENT - WE DO NOT TAKE RETURNS.

SHIPPING AND HANDLING *for U.S. Orders*

- * We ship UPS ground.
- * Your order will arrive with in 1-2 weeks, possibly sooner depending on your location.
- * Art of the Midwest will ship per Distributor's instructions and will include ALL shipping costs on invoice or use Distributor's shipping / freight account number.

SHIPPING AND HANDLING *for International Orders*

- * Art of the Midwest will ship per Distributor's instructions and will include ALL shipping costs on invoice or use Distributor's shipping / freight account number.
- * International orders are shipped through the U.S. Post Office unless otherwise instructed.
- * All bank transfer fees and exchange rate differences will be added to the final invoice.
